

AMERICA'S BOATING CLUB Minnetonka Power Squadron (MPS) ISLAND USER (DOCKAGE) FEES FOR 2019



Eligible members must complete this form to apply for a Streater Cove island use (docking) sticker for 2019. Island use is subject to the Island Rules and is at the sole discretion of the Executive Committee. Each member household using Streater Cove shall be required to pay their own island use fee regardless of boat ownership.

DOCKING STICKERS ARE ONLY ISSUED AND VALID TO ELIGIBLE MEMBERS WHO HAVE MET THE FOLLOWING THREE REQUIREMENTS:

- 1) RECEIVED ONE MERIT MARK IN THE PREVIOUS TWO YEARS, or MET THE "RULE OF 70", or HAVE 25 YEARS OF RECOGNIZED SQUADRON MEMBERSHIP (see last page).
- 2) PASSED BOAT HANDLING (or other MPS recognized ADVANCED course).
- 3) BE PAID CURRENT, AND REMAIN SO, IN THEIR ANNUAL NATIONAL AND MPS DUES.

There is a \$25 late fee for all requests received after May 1, 2019.

“Rule of 70” and “25 Year Member” exception to Merit Mark requirement:

Again for 2019: “Rule of 70”. As started in the 2013 boating season: “Those current squadron members or returning member applicants who have earned at LEAST 5 Merit Marks and reached the age of 60 or greater within the current calendar year shall be relieved of the requirement of having earned a Merit Mark within the past two years PROVIDED THAT, WHEN THEIR AGE AND YEARS OF SQUADRON MEMBERSHIP ARE ADDED TOGETHER, THAT SUM SHALL EQUAL 70 OR MORE”.

In addition, all members with 25 or more years of recognized, continuous squadron membership shall be relieved of the Merit Mark requirement for island use permits. If you are eligible for either Rule of 70 or a 25 year member and claiming such for your 2019 Island Use Permit, please state which applies and INCLUDE THE MEMBERS BIRTHDATE (DOB) if claiming Rule of 70. Thank you.
